

Mayor Hartman opened the regular session of the Board of Works at 6:30 pm at 215 South Broadway.

The minutes from the November 6th meeting were presented. Mr. Haywood made a motion to approve the minutes and Mr. Johnson seconded the motion. The motion passed with all in favor.

Payments and Vouchers Pay Period 10/23 to 11/5 in the amount of \$36,511.30 2022 Longevity Pay in the amount of \$6,628.81 Pastevine DR X3 to Versiel 1 Vouchers for the period 11/4 to 11/17 in the amount of \$187,968.01 Mr. Johnson made a motion to approve the claims and vouchers as presented and Mr. Haywood seconded the motion. 
Planning & Community Development

City Planner Vivian Likes reported that the final mural for the Patronicity Grant has been completed. She is now working on the final grant report.

Police Department

Police Chief Mark Heffelfinger presented Special Event Requests for the Butler Christmas Festival, the Laving of Wreaths Across America and Shoppe with Elves. There was discussion. Mr. Johnson made a motion to approve all three events and Mr. Haywood seconded the motion. The motion passed with all in favor.

Fire Department

Fire Chief Jimmie Eck reported that he is waiting on one more quote for a sign at their Training Facility. The lowest price that he currently has for a lighted box sign is \$10,000.

Clerk-Treasurer

Clerk-Treasurer Angela Eck reported that she has received information on the Health Insurance Renewal for 2024. PHP has presented a 19.2% savings, which equates to about a \$50,000 savings for the year. She did receive quotes from several other companies, but they were all higher.

City Attorney Don Stuckey stated that the Board needs to approve staying with PHP as the insurance carrier in a motion.

Mr. Johnson made a motion to remain with PHP for health insurance and Mr. Haywood seconded the motion. The motion passed with all in favor.

Clerk-Treasurer Eck reported that the Council approved an ordinance Amending and Updating the Established Rules for the Prevention of Identity Theft of Customers of the City of Butler Utilities at their meeting on November 6th. She asked that the Board make a motion approving the updated policy. Mr. Johnson made a motion to approve the updated "Red Flag Rules" and Mr. Haywood seconded the motion. The motion passed with all in favor.

Clerk-Treasurer Eck presented the following Special Payment Requests:

Mr. Haywood made a motion to approve the Special Payment Requests and Mr. Johnson seconded the motion. The motion passed with all in favor.

<u>Mayor</u>

Mayor Mike Hartman asked the Board to approve a Phase I Environmental Study of Susie Park. He has had discussion with several groups on possibly selling or donating the land (2.75 acres) to the food pantry and/or daycare. He has two quotes for the environmental survey: JPR for \$1,800 and Nulnventa for \$2,500. Mr. Haywood made a motion to approve the quote from JPR at a cost not to exceed \$1,800 and Mr. Johnson seconded the motion. The motion passed with all in favor.

Mr. Kent Likes asked Mayor Hartman why the City was paying for the environmental study expense. Mayor Hartman stated that the potential purchaser(s) may not want the property, depending upon what could be found there. Mayor Hartman also stated that the food pantry is no longer interested in the property.

Mrs. Teri Fritch asked that if the Food Pantry is no longer interested, why spend the money. Mayor Hartman stated that no one will be interested in the property if there could be potential environmental issues. It is costing the City to mow it, why not try to sell it.

Mr. Gavin Fritch asked why the non-profit group interested in it isn't paying for the study. There was discussion back and forth. Mr. Fritch also suggested that the Community Gardens (across the street) be tested as well. The City should be more concerned with what could be found in the produce being currently grown there and being consumed by residents.

Mayor Hartman stated that the study would be a benefit to the City and would tell him how to market the property.

Mr. Kent Likes asked if the Day Care meetings are open to the public. If they are a non-profit, they are required to be open to the public. Mayor Hartman stated that he is part of the group trying to get if off the ground and will let him know when the next meeting is held.

Mr. Gavin Fritch stated that the Day Care people should be at this meeting asking for an environmental study.

City Attorney Stuckey stated that the seller of a property has to sign a closing affidavit stating that there are no hazards on the property they are selling. The City has to know what is in the ground before attempting to sell it.

More discussion back and forth on this issue.

Mr. Haywood made a motion to adjourn at 6:55 and Mr. Johnson seconded the motion. The motion passed with all in favor.
